Research Showcase Abstract Submission LINK

The CFDR Research Showcase provides a unique opportunity for authors to present their research as either a 10-minute oral presentation (invited) or an ePoster.

Format

- Each Research Showcase will feature a 30–45-minute keynote presentation by a CFDRfunded researcher
- The keynote presentation will be followed by oral presentations (10 minutes + 5 minutes for questions) of selected abstracts
- ePosters from accepted abstracts will be displayed on the Research Showcase platform during the Research Showcases.
- Abstracts may be in English or French
- All oral presentations will be in English; posters can be in English or French

Benefits

- The CFDR Research Showcase provides an excellent opportunity for dietitians and students/trainees to showcase their work to an audience of peers from across Canada.
- Abstracts selected for a 10-minute oral presentation:
 - will be presented during one of the Research Showcases
 - o will be posted on the CFDR website
 - o will be published in the Fall 2026 edition of the Canadian Journal of Dietetic Practice and Research (CJDPR) (Author must present at the Research Showcase)
- Abstracts selected for an ePoster:



- will be displayed during the Research Showcases
- will be posted on the CFDR website
- will be published in the Fall 2026 edition of CJDPR (Author must prepare an ePoster for the Research Showcase)

Notes: CFDR will decide which abstracts will be assigned to oral presentations or ePosters based on the recommendations of the Abstract Review Committee. Details on dates and timing for presentations/ePosters will follow once final programming decisions have been made.

All decisions of CFDR are final.

Eligibility

- Only ONE abstract may be submitted per Presenting Author.
- Presenting Authors may be co-authors on other abstracts.
- Abstracts must represent original research.
- Abstracts must not have been presented and/or published previously in association with a scientific or professional conference or journal.
- In the case of a large and/or multi-faceted project, it is acceptable to submit a new abstract to report on previously unreported aspects of the project.

- Abstract submission portal opens on October 3, 2025
- Abstract submission portal closes on November 14, 2025 at 11:59 PM EST
 - You will receive notification when your abstract has been submitted, and the fee paid
 - Your co-authors will receive notification after November 14, 2025
 - You will receive a link that will allow you to revise your abstract until November 14, 2025 at 11:59 PM EST

There is a \$45 NON-REFUNDABLE submission fee for ALL abstracts.

- You will be required to pay the fee when you submit your abstract
- "CFDR Registration" will appear on your credit card statement
- The abstract submission fee includes registration for the Research Showcase (both
- Payment of the abstract submission fee does not guarantee acceptance of abstract



ABSTRACT CRITERIA

- The abstract MUST be a structured abstract and MUST include results from COMPLETED research
- Abstracts may be submitted in English or French
- All abstracts will be peer-reviewed (blinded review)
- Reviewers will consider elements (e.g., objectives, methods, results, conclusions, significance, and writing quality)
- The Abstract Review Committee reserves the right to decline any submitted abstract

ABSTRACT WRITING GUIDE AND FORMAT INSTRUCTIONS You will be asked to complete the following fields.

ADMINISTRATIVE INFORMATION

Contact Details (of First Author)

First name, last name, organization, city, province, email address

ABSTRACT DETAILS

Abstract Title

- Please enter the title of your abstract
- Please use sentence case
- The first letter after a colon, proper names, and acronyms, may be either in sentence case or in uppercase

Format Example:

Evaluation of tools: Participant satisfaction in Toronto using the Dining Assessment Protocol (DEP)

List ALL Authors (including abstract submitter)

- First name, last name, organization, city, province, email address
- Co-authors will receive notification of abstract submission after November 14, 2025

Abstract

- There is a 2200-character limit (including spaces)
- The abstract is text only



- Tables are not allowed
- Do not insert extra carriage returns between paragraphs
- Do not include the abstract title, names of authors, or research support in the body of the abstract
- Abstracts must contain the following 6 sections:
 - Introduction
 - Objectives
 - Methods
 - **Results** (This must be a summary of results to support the conclusions)
 - Conclusions (It is not satisfactory to say "the results will be discussed")
 - **Significance** (to the field of dietetics)

Reviewers base their decisions solely on the written information submitted. Chances of having an abstract accepted are increased by the submission of a clearly written, precise, informative abstract. If accepted, your abstract becomes the permanent published record of your work. Consider the following when writing the abstract:

- Does the abstract describe a research study that would be of interest to a wide variety of DC members?
- Is the study or project advancing research and practice by describing new findings?
- Is it evident that your project has been completed?

Reviewers also base their decisions on the scientific merit, relevance to dietetics/nutrition, validity of results, and summary of results to support the conclusions and original research.

Abstracts will NOT be returned for revisions.

- Assigning copyright to DC and CFDR does not mean you cannot submit a full manuscript with similar content elsewhere.
